

### The clinical trial contract

In an attempt to avoid double work and long timelines, we would like to streamline our juridical review for contracts related to clinical trials.

It is possible we have worked with you before and therefore we already have performed a review on your contract templates. There are several possibilities:

- You are using the exact same contract template as a previous study. In this case we would like you to reference the previous contract and send us your new contract. No fee will be charged.
- Your contract template has been amended with minor changes. Please provide us a contract version with track changes clearly indicating the changes.
- If you have not worked with AZ Groeninge before for clinical trials or your contract has been significantly changed, your contract will need extensive reviewing and an independent juridical advisor will be consulted. Therefore a fee will be asked of 350€.

It is also possible to work with the pharma.be contract as an alternative to avoid these costs.

### Contractual parties

Please take the following points into consideration when creating the clinical trial agreement for AZ Groeninge. Please consider that the investigators are self-employed and therefore they need to be acknowledged as party other than the institution.

Each party will sign the contract, please foresee the correct title and names in the signature area. (Please note that the Institution will sign for the pharmacy) Each signing party needs an original contract, thus please foresee the correct number of copies.

In the financial overview, please foresee a separate appendix describing the requested activities and corresponding budget foreseen for each individual party (the PI separate, the Laboratory separate, the radiology department separate,....)
